Vermont Green FC acknowledges we are playing home games on land that is part of the legacies and trauma of indigenous dispossession. We are guests on this land, which has served as a site of meeting and exchange among indigenous peoples for thousands of years and is home to the Western Abenaki People.

HONORING AFRICAN AMERICAN HISTORY



Vermont Green FC is playing *Lift Every Voice and Sing*, often referred to as “The Black National Anthem,” today to celebrate African American freedom and achievement and respect for all cultures. The Club started this tradition to honor Juneteenth - the effective end of slavery in the United States - and will continue honoring our shared history for the rest of the season. The hymn was written as a poem by NAACP leader James Weldon Johnson in 1900. His brother, John Rosamond Johnson (1873-1954), composed the music for the lyrics. At the turn of the 20th century, Johnson’s lyrics eloquently captured the solemn yet hopeful appeal for the liberty of Black Americans and was later adopted by NAACP and prominently used as a rallying cry during the Civil Rights Movement of the 1950s and 1960s. EXPANDING ACCESS TO SOCCER AND EQUITABLE PLAY IN VERMONT

Juba Star Football Club, an affiliate of the non-profit Somali Bantu Community Association of Vermont, works to expand access to soccer and equitable play in the state. They've built a remarkable community asset through the beautiful game. We partnered with them to raise money to fund their participation in the Louisville International Outdoor Cup, a Somali-led tournament hosting top talent from around the country.



We are overjoyed to announce we achieved our fundraising goal of \$8,000 to support the operations of this fantastic organization that continues to make our communities more inclusive, safe, and comfortable for historically underrepresented Vermonters.

King Street Center

Vermont Green Football Club is partnering with King Street Center to make matches more accessible and inviting to historically marginalized communities. The program is focused on building community ties between Vermont Green Football Club players and King Street Center youth and families. Players will join King Street Center youth each week to engage in soccer activities and discuss their path toward playing soccer at the highest levels. Vermont Green will host King Street Center youth at weekly practices and donate free tickets through its “Spread the Love” initiative so they can attend home games throughout the season. Players, staff, and youth will also spend time focusing on how soccer can be a powerful catalyst for a more environmentally sustainable and socially just world.

Juba Star FC

We are partnering with Juba Star Football Club to expand access to soccer and work towards equitable play in the state. Juba Star FC is a Somali Bantu-led organization that has operated in the state since 2006. The organization was established to provide a safe space for the growth and development of former refugee and immigrant youth in Vermont. The organization runs free soccer clubs for youth and adults, ages 14 and older, and provides assistance with transportation to games and practices, and mentorship for youth.

Anti Racist Soccer Club

Anti-Racist Soccer Club is a coalition of players, clubs, and experts fighting racism in American soccer. The ARSC membership is open to teams and leagues at the professional and youth levels, supporter groups, and any other soccer-affiliated organization. ARSC works with interested parties to develop a ten-point plan anti-racism framework that is unique to that community. ARSC monitors and evaluates member plans to ensure accountability.

COMMUNITY SPOTLIGHT: *LABOR NIGHT*



In recognition of VGFC's mission, the Vermont State Labor Council, AFL-CIO is partnering with the Club to support each other's work in the community. This partnership affirms the relationship between athletes and owners as one in the same with the worker and bosses.

Tonight we are celebrating a first-of-its-kind sports partnership. Vermont Green FC's Labor Night is a demonstration of solidarity between athletes and workers, as well as solidarity with all living beings on our shared planet.

Social and economic justice are integral to environmental justice, and the labor movement has a long history of leadership on both fronts. VGFC General Manager Connor Tobin was on the Organizing and Bargaining Committees for the formation of the United Soccer League Player Association (USLPA). The USLPA is the collective bargaining representative for all USL Championship and USL League One professional players who are signed to a standard USL agreement. The USLPA does not represent amateur players signed to an amateur playing agreement or loaned players.

The benefits of being a union member extend beyond the workplace. We are proud to announce our partnership by also offering a 10% discount on tickets for all VT AFL-CIO affiliated union members.
